RESOLUTION NO. 2022-8

A RESOLUTION AUTHORIZING THE TOWN OF SUGAR CITY TO RAISE WATER RATES FOR IN-TOWN AND OUT-OF-TOWN WATER USERS

WHEREAS, the Town of Sugar City provides water to its residents; and

WHEREAS, the cost of purchasing water has increased; and

WHEREAS, additional costs for water distribution are increasing; and

WHEREAS, the Town of Sugar City wants to continue to provide water to its current users; and

WHEREAS, the Town of Sugar City needs to increase water rates to stay fiscally solvent.

NOW, THEREFORE, BE IT RESOLVED by the Trustees of the Town of Sugar City as follows:

1. The monthly surcharge for in-town water customers shall be increased by \$3.00 from \$19.06 to \$22.06.
2. The monthly surcharge for out-of-town customers shall be increased by \$3.00 from \$21.00 to \$24.00.
3. The newly adopted rates shall go into effect on June 1, 2022.
4. The Board of Trustees authorizes the Mayor of the Town of Sugar City to sign the necessary paperwork.
